

**Amendment to Agreement Between Shelby County Government and
Ensafe, Inc.
Contract Number CA2300362-1**

THIS AMENDMENT (hereinafter "Amendment") is made and entered into this 24th day of January, ~~2023~~ ²⁰²⁴ by and between Shelby County Government (hereinafter "County") and Ensafe, Inc. (hereinafter "CONSULTANT").

WHEREAS, the parties previously entered into an agreement (hereinafter "Agreement") dated September 1, 2022, for construction engineering and inspection (CEI) services for the Big Creek National Disaster Resiliency- Shady Oaks Pumping Station Improvement project; and

WHEREAS, the contract with the contractor performing the construction improvements was executed on March 9, 2023 and was issued a Notice to Proceed on April 14, 2023 (start date) with the contract period through December 23, 2023; and

WHEREAS, the contract with the construction contractor needs to be extended to allow for completion, final work, and closeout; and

WHEREAS, the COUNTY now has the need to extend the contract for CEI services to manage the remaining work; and


WHEREAS, the parties now desire to enter into this Amendment to revise the terms of the contract.

NOW, THEREFORE, for and in consideration of the mutual promises of the parties to this agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto do hereby agree as follows:


1. Section II of the Agreement entitled TERM AND COMPENSATION is hereby amended to reflect the additional time of one hundred (100) calendar days. The new contract period shall end April 1, 2024.
2. The conditions of the original Agreement, except as amended herein, shall remain in full force and effect.

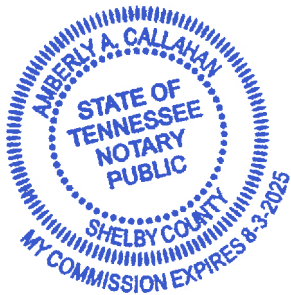
